# Licensed Professional Counselor (LPC)

MCL 333.18101 MCL 333.18107

### **Education**

Master's or Doctoral degree in a qualified counseling program from an accredited college or university

### Licensure

- 18 years of age or older;
- Education requirement; and
- At least 2 years of counseling experience under supervision of LPC.

- If applicant has doctoral degree in counseling, the Board may decrease required length of counseling experience under the supervision of LPC to 1 year

# **Scope of Practice**

"Practice of counseling" or "counseling" means the rendering to individuals, groups, families, organizations, or the general public in accordance with accepted and established ethics a service involving clinical counseling principles, methods, or procedures for the purpose of achieving social, personal, career, and emotional development and with the goal of promoting and enhancing healthy selfactualizing and satisfying lifestyles whether the services are rendered in an educational, business, health, private practice, or human services setting. "Clinical counseling principles, methods or procedures" means one or more of the following:

- Psychotherapy, the diagnosis and treatment planning for mental and emotional disorders, and evaluation
- Selecting, administering, scoring and interpreting assessments, tests and appraisals that are designed to assess individual's aptitudes, interests, attitudes, abilities, achievements and personal characteristics
- Psychoeducational consulting, which is assisting a consultee that is working with an individual, small group, or organization by identifying problems, strengths, and weaknesses and making recommendations for the implementation of preventative or remedial strategies
- Counseling techniques, which is the application of basic counseling and psychotherapy skills and theories in the counseling process for the purposes of establishing and maintaining the counseling relationship; diagnosing the problem; formulating a preventative, treatment, or rehabilitative plan; and facilitating appropriate interventions

# **Scope of Practice**

- Diagnosing the problem means the identification of the problem through the application of recognized counseling techniques and psychotherapy skills and theories, including the use of the classifications and diagnoses in the Diagnostic and Statistical Manual for Mental Disorders, obtained through the successful completion of a qualified program
- Behavioral modification techniques, which means assisting clients in identifying maladaptive or harmful behaviors and replacing them with adaptive and helpful behaviors
- Referral, including determining the need for referral to 1 or more statutorily regulated mental health professionals whose expertise, skills and competence are appropriate to the problems of the individual, informing the individual of the referral, and communicating as appropriate with the professional to whim the individual has been referred
- Preventative techniques, which is assisting a client in maintaining mental and emotional well-being and preventing emotional distress and mental illness
- Establishing a counseling plan for the treatment of 1 or more of the following disorders of an individual, couple, group or family:
- An emotional disorder
- A mental disorder
- An addiction disorder
- A physician disorder that requires a counseling intervention
- Preventing and treatment mental and emotional disorders, including use of crisis intervention

# Limited Licensed Professional Counselor (LLPC)

## **Education**

Master's or Doctoral degree in a qualified counseling program from an accredited college or university, or a degree determined by the department in consultation with the board to be substantially equivalent to a counseling degree from a qualified program

# Licensure

- 18 years or older; and
- Education requirement

# **Scope of Practice**

Scope of practice is the same as LPC but must must be performed in a program of counseling experience under appropriate supervision.

# Supervision

Practice of LLPC must be confined to a program of counseling experience under the supervision of a LPC. (Note: LPC may not provide supervision unless the LPC has completed training in supervision.)

#### Licensure

Certification requires:

 6,000 hours full or part-time clinical counseling experience working with substance use disorder clients at a program licensed by the state of Michigan as a substance use disorder services provider or Michigan Certification Board for Addiction Professionals (MCBAP)-approved alternative program. **Scope of Practice** 

- An academic degree in social science or human service field from an accredited institution can be used for credit towards hours of experience:
  - 1,000 hours credit for Associate's degree 2,000 hours credit for Bachelor's degree
- Total of 300 education hours:
  - 180 hours specific to substance use disorders
  - 120 hours may be related to the Alcohol and Drug Counselor (ADC) Domains
    - \* Domain I: Screening, Assessment and Engagement
    - \* Domain II: Treatment Planning, Collaboration, and Referral
    - \* Domain III: Counseling
    - \* Domain IV: Professional and Ethical Responsibilities
  - 6 hours must be face-to-face, MCBAP-approved education in behavioral health practice ethics or MCBAP-approved alternative
  - For education credits to count toward certification, the content of educational activity must meet the definition of SPECIFIC or RELATED
    - \* SPECIFIC: Title, goals, objectives or course outline are specifically focused on alcohol, tobacco, and/or other drug use issues. Keywords in course titles are: substance abuse, substance use disorder, drug addiction, chemical dependency, alcohol, tobacco, drug use or co-occurring disorders. General courses in clinical theory and therapeutic methods will not count if not specific to substance use disorder specialty services
    - \* RELATED: Title, goals, objectives or course outline content clearly indicate the course content address development of any of the domains but the content may not directly address substance use disorder issues (e.g., general counseling skills, clinical theory, therapeutic methods)

- Sign and adhere to current MCBAP Counselor Code of Ethical Standards

### Licensure

- Must submit the Certified Advanced Drug & Alcohol Counselor Documentation of Experience form for <u>each</u> program where accumulated experience
- Experience must be in the IC&RC/AADC Performance Domains
- 100 hours of direct supervision in substance use disorder services, post-Master's degree, specific to the IC&RC/AADC Performance Domains (minimum of 25 hours for each Domain)

# (Educational) Limited License Marriage and Family Therapist (LLMFT)

LARA Bureau of Professional Licensing: Marriage and Family Therapy Licensing Guide

## **Education**

Graduate from an educational program that is accredited by the Commission on Accreditation for Marriage and Family Education (COAMFTE), OR Graduate with a master's or doctoral degree from a regionally accredited institution that includes

a) three courses (at least 6 semester or 9 quarter hours) in family studies; b) three courses (at least 6 semester or 9 quarter hours) in family therapy methodology; c) three courses (at least 6 semester or 9 quarter hours) in human development, personality theory, or psychopathology; d) at least 2 semester or 3 quarter hours in ethics, law and standards of professional practice; e) at least 2 semester or 3 quarter hours in research.

### Licensure

- Education requirement
- Eight-month supervised practicum experience that includes at least 300 direct client contact (does not apply to applicant with doctoral degree from COAMFTE-accredited program)
- Verification of licensure in any state where licensed, even if no longer active;

- Application with fee

# **Scope of Practice**

Post-graduate supervised practice requirement is to be completed in a healthcare facility or other setting acceptable to the Board. The limited license holder must accrue at least 1,000 direct client contact hours before they can be eligible for full licensure. At least half of the required minimum must be spent providing services to couples or families.

### Supervision

Must have 200 hours of direct supervision while accruing 1,000 direct client hours. Up to half of the supervision hours may be done in a group setting with three to six supervisees; a full 100 hours must be done one to one or one to two.

# Limited License Master Social Worker (LLMSW)

Limited license is a license for applicants used to obtain 4,000 hours of supervised social work experience and take the examination. Can be renewed up to 6 times.

- Master's degree
- Application and fee
- Criminal background check and fingerprints

May only practice in an agency, health facility, institution, or other Board-approved entity. Scope of practice is the same as a LMSW but requires supervision of practice.

Supervision by licensed social worker required.

# **Limited License Bachelor** Social Worker (LLBSW)

## **Education**

Bachelor's degree from CSWE-accredited educational program

# Licensure

Limited license is a license for applicants used to obtain the 4,000 hours of required supervised social work experience and take the examination. Can be renewed up to 6 times.

- Education requirement
- Practice under the supervision of a licensed master's social worker
- Application with fee
- Criminal background check and fingerprinting

# **Scope of Practice**

 May only practice in an agency, health facility, institution, or other Board-approved entity. Scope of practice is the same as a LBSW but requires supervision of practice.

# Licensed Bachelor's Social Worker (LBSW)

### **Education**

Bachelor's degree from CSWE-accredited educational program

### Licensure

- Education requirement
- Successfully pass the Association of Social Work Boards (ASWB) Bachelor's exam (75% score required to pass)
- Completed at least 4000 hours (two years of full-time, or the equivalent in part-time) of post-bachelor's degree experience in the practice of social work at the bachelor's level under the supervision of a fully licensed master's social worker.

## **Scope of Practice**

Practice of social work at the bachelor's level means all of the following applied within the scope of social work values, ethics, principles, and skills:

- The application of social work theory, knowledge, methods, and ethics to restore or enhance social, psychosocial, or biopsychosocial functioning of individuals, couples, families, groups, organizations or communities, with particular attention to the person-in-environment configuration.
- Social work case management and casework, including assessments, planning, referral and intervention with individuals, families, couples, groups, communities, or organizations within the content of social work values, ethics, principles and skills.
- Helping communities, organizations, individuals, or groups improve their social or health services by utilizing social work practice skills.
- The administration of assessment checklists that do not require special training and that do not require interpretation.
- The practice of social work at the bachelor's level does not include the practice of medicine or the practice of osteopathic medicine and surgery, including, but not limited to, the prescribing of drugs, the administration of electroconvulsive therapy, the practice of psychotherapy, and other advanced clinical skills or the administration or interpretation of psychological tests, except as permitted under the administration of assessment checklists that do not require special training and do not require interpretation.

# Licensed Master's Social Worker (LMSW)

### Education

Master or Doctoral degree in Social Work from approved program

#### Licensure

Requires a master or doctoral degree in social work from board-approved program <u>and</u> at least 2 years of practice in social work at master's level under the supervisions of LMSW.

May receive licensure by examination or licensure by endorsement (if licensed in another state).

- Licensure by examination requires:
- Master's degree from CSWE-accredited program
- At least 4,000 hours of post-degree social work experience completed over at least a 2-yr period. If experience gained in MI, must hold LLMSW License. Experience must be completed in setting that includes work in the area of designation (Clinical, Macro, or both)
- Verification of licensure in any state where licensed, even if license is no longer active
- Pass either Clinical or Advanced Generalist (Macro) examination conducted by Association of Social Work Boards (ASWB)
- Fee with application
- Criminal background check and fingerprinting *For clinical designation*:
- Master's or doctoral degree from board-approved accredited school of social work
- Pass ASWB exam
- Minimum 4,000 hours of post-degree social work experience accrued over not less than 2 years
- Qualifying experience must include 1 or more of the following:
- assessment, treatment and intervention methods that utilize a special and formal interaction between a social worker and an individual, a couple, a family, or a group in which a professional relationship is established;
- advocating for care;
- protecting the vulnerable;
- providing forensic practice functions;
- increasing social well-being;
- providing education and resources;
- providing psychotherapy;
- providing case management for complex and high-risk cases;
- serving on community committees; and
- providing clinical supervision or direction of clinical programs.
- \*LMSW employed by a school district required to meet additional approval requirements.

## **Scope of Practice**

All of the following applied within the scope of social work values, ethics, principles, and advanced skills:

- The advanced application of the knowledge of human development and behavior and social, economic, and cultural institutions.
- The advanced application of macro social work processes and systems to improve the social or health services of communities, groups, or organizations through planned interventions.
- The application of specialized clinical knowledge and advanced clinical skills in the areas of assessment, diagnosis, and treatment of mental, emotional, and behavioral disorders, conditions, and addictions. Treatment methods include the provision of advanced social work case management and casework and individual, couple, family, or group counseling and psychotherapy whether in private practice or other settings.

The practice of social work at the master's level *does not include* the practice of medicine or the practice of osteopathic medicine and surgery, including, but not limited to, the prescribing of drugs or administration of electroconvulsive therapy.

Temporary approval and continuing approval are required prior to receiving full approval. Requirements for temporary, continuing, and full approval are as follow: Temporary approval

- Education requirement
- Minimum 500 clock-hour supervised social work practicum
- Recommendation for temporary approval from a Michigan school of social work training program Continuing approval
- Temporary or continuing temporary approval as a school social worker in the previous school year
- Employer request for continuing temporary approval Full approval
- Education requirement
- Temporary and continuing temporary approval with one year full time successful employment while working as a school social worker under temporary or continuing approval

# **Scope of Practice**

School social worker may function in any of the following roles:

- Provide individual and group counseling to students and their families in need of assistance utilizing an ecological framework addressing variations in development and learning, as well as reciprocal influences of home, school, and community.
- Provide consultation, collaboration, and advisement services to students, their family members and school staff regarding students' social, emotional, and behavioral status impacting learning, development, mental health, and school success.
   Encourage developmentally appropriate student self-determination and selfadvocacy.
- Implement school social work services within a multi-tiered intervention model for programs and services.
- Provide instruction, modeling and coating to students, parents and school staff in the implementation of effective behavior intervention strategies and techniques.
   Provide ongoing guidance and training services to parents and school staff on topics pertinent to the development, mental health and learning needs of students.
- Provide liaison, coordination, and case management services with schools, families, community agencies, and other resources to influence positive school outcomes for students.
- Develop functional behavior assessments and behavior intervention plans to facilitate successful learning and socialization opportunities. Provide services and disseminate information to encourage school wide positive behavior supports.
- Identify and coordinate accommodations and modifications of school environment for a student to obtain access to general education curriculum and instruction.

## **Scope of Practice**

- Provide support to facilitate successful transitions in areas that affect students' learning opportunities.
- Provide crisis prevention, planning and intervention services, including assessments of the impact of trauma on development, learning and school performance.
- Provide comprehensive written reports of assessments and evaluations of students that specifically address the reasons for referral. Utilize multiple methods of collecting data and provide appropriate measurable goals for intervention and anticipated outcomes from service.
- Provide and interpret assessments and evaluations to determine eligibility for special education and identify needs for programs and services.
- Utilize home and community settings, as appropriate, to collect assessment information, collaborate with parents, and provide interventions.
- Collaborate with parents, multidisciplinary evaluation team members, school administrators, and other community agencies to develop an accurate understanding of a student's disability, the impact of the disability on students' educational performance, and provide information regarding whether behaviors and school performance are attributable to manifestations of the disability.
- Conduct needs assessment and advocate for policies, programs, and services to meet educational and mental health needs of all students, and to support safe school climates conducive to learning.
- Identify issues that may interfere with student development, learning and school success.
- Identify and work to prevent bias, prejudice, discrimination and oppression that interfere with individual rights in the educational process.

- The post-master's degree experience requires:
- (a) The experience consists of at least 2,000 clock hours completed under the supervision of a psychologist licensed in Michigan, eligible for licensure in Michigan, or who is licensed or certified at the independent practice level in the state where the experience is obtained.
- (b) The experience is accumulated at not less than 16 clock hours per week and not more than 40 clock hours per week. (c) If an appropriate supervising psychologist is unavailable, the applicant may seek Board approval for supervision by a person who has been granted a master's degree in psychology and who has acquired not less than 3 years (6,000 clock hours) of post-master's degree experience in the practice of psychology, or another individual approved by the board.
- (d) The supervisee shall meet individually and in person with his or her supervisor weekly for a minimum of 4 hours a month, during which all active work functions and records of the supervisee are reviewed.
- (e) The supervisee shall function as a psychologist using generally accepted applications of psychological knowledge and techniques acquired during the supervisee's education and training.

## **Scope of Practice**

Rendering of services involving the application of principles, methods and procedures of understanding, predicting, and influencing behavior for the purposes of the diagnosis, assessment related to diagnosis, prevention, amelioration, or treatment of mental or emotional disorders, disabilities or behavioral adjustment problems by means of psychotherapy, counseling, behavior modification, hypnosis, biofeedback techniques, psychological tests, or other verbal or behavioral means. *Shall not include* the practice of medicine such as prescribing drugs, performing surgery or administering electro-convulsive therapy.

### Supervision

Supervision by a licensed psychologist; The supervisee shall function as a psychologist using generally accepted applications of psychological knowledge and techniques acquired during the supervisee's education and training. Practice with a limited license for those with less than 10 years of limited license experience must meet individually and in person with the supervisor for a minimum of 2 hours per month. Practice with a limited license for those with more than 10 years of limited license experience must meeting individually and in person with the supervisor for a minimum of 1 hour per month.

Doctoral degree in psychology or closely related field

### Licensure

A doctoral limited license is required before completing post-graduate supervised work experience required for full license.

- Graduate of board-approved educational program
- At least 2000 hours of internship experience gained in 2 years or less
- Complete training on identifying victims of human trafficking (effective 2021)

<u>Temporary Limited License:</u> The Doctoral Educational Limited license (TLLP) is for individuals enrolled in a doctoral degree program for psychology.

- Certification of Enrollment in a Doctoral Degree Program for Psychology form from accredited school.
- After this license is issued, eligible to take the EPPP

# **Scope of Practice**

Supervision of a licensed psychologist. Post-doctoral practice and training must be in a hospital, clinic, institution. or other boardapproved arrangement for the training. Practice with a limited license for those with less than 10 years of limited license experience must meet individually and in person with the supervisor for a minimum of 2 hours per month. Practice with a limited license for those with more than 10 years of limited license experience must meeting individually and in person with the supervisor for a minimum of 1 hour per month.

## **Scope of Practice**

Rendering of services involving the application of principles, methods and procedures of understanding, predicting, and influencing behavior for the purposes of the diagnosis, assessment related to diagnosis, prevention, amelioration, or treatment of mental or emotional disorders, disabilities or behavioral adjustment problems by means of psychotherapy, counseling, behavior modification, hypnosis, biofeedback techniques, psychological tests, or other verbal or behavioral means. Shall not include the practice of medicine such as prescribing drugs, performing surgery or administering electro-convulsive therapy.

The Michigan Board of Education Standards of Practice require competency in:

- Prevention and intervention work at a variety of levels (district, school, classroom, small group, individual student) to promote positive social-emotional and academic outcomes among students.
- Consultation about and implementation of curriculum-based approaches to academic assessment, and functional approaches to behavioral assessment.
- Collection, interpretation and use of data for a variety of purposes beyond just determining special education eligibility, such as for the purposes beyond just screening, instructional and intervention planning, evaluating fidelity of intervention implementation, monitoring of student progress, and evaluation of intervention effects.
- Evaluation and adaptation of these assessment and intervention practices such that they are responsive to the needs of, and effective for, students from culturally and linguistically diverse backgrounds.

# **Scope of Practice**

The practice of nursing is defined as the systematic application of substantial specialized knowledge and skill, derived from the biological, physical and behavioral sciences, to the care, treatment, counsel, and health teaching of individuals who are experiencing changes in the normal health processes or who require assistance in the maintenance of health and the prevention or management of illness, injury, or disability. A Nurse Practitioner focuses on the performance of comprehensive assessments; providing physical examinations and other health assessments and screening activities; and diagnosing, treating, and managing patients with acute and chronic illnesses and diseases. Nursing care provided by a NP includes ordering, performing, supervising, and interpreting laboratory and imaging studies; prescribing pharmacological and nonpharmacological interventions and treatments that are within the nurse practitioner's specialty role and scope of practice; health promotion; disease prevention; health education; and counseling of patients and families with potential, acute, and chronic health disorders.

NPs may prescribe a non-scheduled prescription drug without delegation by a physician. NP may prescribe controlled substances Schedule II-V only when delegated by the supervising physician.

### Supervision

Some specified tasks may be performed without physician delegation or supervision. Those duties and responsibilities of a RN can be performed without physician supervision. Those acts/duties that fall under "the practice of medicine" require physician supervision.

A school nurse certification means that an interim, standard or professional school nurse certificate has been issued to a RN by the state board of education School nurse certification criteria:

  Credits beyond those required for a registered nurse, to be applied toward certification as a school nurse, shall be earned through an approved teacher education or nursing education institution program. The state board of education will determine the acceptability of credits leading toward programs approved by it.
- A RN with a currently valid license issued by the state board of nursing employed as a school nurse by an employing school district for a period of not less than 1 school year, and whose experience is successful as determined by the state board of education upon the recommendation of the employing school district, is eligible for a professional school nurse certificate.

- Organization and administration of the school health program, including necessary skills or understanding of curriculum development
- Learning theory
- Guidance and counseling

#### Professional school nurse certificate:

- 3 years of successful experience as a school nurse as determined by the state board of education upon recommendation of the employing school district.
- A baccalaureate degree in nursing or a health-related field.

## **Scope of Practice**

A school nurse shall:

- Assess and evaluate the health and development status of students through nursing diagnosis and the use or appropriate evaluative techniques.
- Interpret nursing assessments of medical evaluations to the students, their parents and school personnel and provide an understanding of implications for the educational performance of students, while recognizing and maintain the confidential nature of the information.
- Plan a course of action and assist students, their parents and school personnel in assuming proper roles for eliminating, minimizing, preventing or understanding the health problems which interfere with effective learning by the student.
- Recommend to parents and appropriate school personnel modifications in the educational program as indicated by the health and developmental status of students.
- Stimulate incorporation of health education in the school curriculum by serving on curriculum committees, serving as a consultant and resource person or participating in teacher-parent education programs.
- Serve as intermediary between the school and the home, private physician, and health and social agencies regarding the health status of students and their needs for consideration in future community health planning.
- Assist students and their families to obtain optimum health and well-being by stimulating behavior change through the educative process, including individual or group counseling.
- Interpret health information when serving as a member of a special education placement committee or other programs in which health information is desirable.
